- Provide a way in which having a food program would not cost too much so the program would be willing to serve healthy meals.

- B-6 comments: Group wants standards for good health and physical activity; physical activity is important for good health; what is important is a combination of food and physical activity; needs to be more training in this area and more participation.
- B-2 comments: Group agrees that it is very important to consume 5 fruits and vegetables during the day; need more "policing" of serving fruits and vegetables; group felt that there are some programs which in difficult times cut corners in focusing on serving fruits and vegetables and educating about them.
- B-8 comments: Group agrees that it is difficult to get into the food program and seems too cumbersome with the paperwork. Many may qualify but are afraid to do all the paperwork.

- K-4 comments: Standards regardless of background; other members said one standard does
  not fit each child and education should be done on an individual basis to fit each child's
